## **SUPERINTENDENT OF SCHOOLS – STEVE WALLACE ON BEHALF OF MICHAEL J. BURKE**

- School Board approved its next five-year Strategic Plan. The Plan consists of four themes: Academic Excellence and Growth, Student-focused Culture, Mental Health and Wellness, and Committed and Impactful Employees.
- The District has new safety measures including staff badges featuring a panic button and an emergency alert system.

## **GROWTH MANAGEMENT – DAGMAR BRAHS, CHAIR**

- The Winchester Assemblage PUD, a 27-acre property, on the east side of S. Military Trail, north of Hypoluxo Rd. was presented. Along with Rezoning, and a Type II Variance, the plan includes 210 two-story townhomes. Thirteen required Workforce Housing units would be purchased in-lieu and would not be built. Motion passed 39 - 8.
- Erickson Senior Living, a 93.5-acre property, on the south side of Boynton Beach Blvd., west of the Turnpike, is seeking approval by PBC for a privately proposed Text Amendment to the Comprehensive Plan. The Text Amendment would revise policies in the Ag Reserve Tier and allow a 2nd location of a Congregate Living Residential (CLR) in the Ag Reserve. The request is for a text amendment only, not a site plan. Motion passed 42 - 3.

## **PRESIDENT'S REMARKS – STEVE WALLACE**

- Thanked the Audit Committee for fulfilling their duties and confirmed the organization's sound financial position.
- COBWRA leadership will attend BCC meetings in order to address the following significant issues that the BCC will be considering: the GL Land Swap; a text amendment to allow a second site specific location in the Ag Reserve for a large CLR (Congregate Living Residential); Essential Housing; and a Commerce land use designation. President Wallace stressed that COBWRA considers what is good for the entire county.

# Featured Presentation: "County and Statewide General **Election Ballot Questions**"

Ed Chase, PBC Director of Intergovernmental Affairs, spoke of the three constitutional amendments that will be on the Nov. 8 Ballot: prohibiting local government to reassess property that has been improved by adding flood resistance measures, vote to abolish the Constitutional Revision Commission, and to grant homestead tax exemptions to those who serve the public such as first responders, teachers and military personnel.

Skip Miller, Housing Leadership Council Director and Michele Jacobs, President/CEO of Economic Council of PBC spoke of the \$200 million bond issue that would be used to increase workforce and affordable housing by granting low interest loans for developers.
